

### RISKS MATERIAL TO OUR COMPANY AND ITS BUSINESS

1. We had negative cash flow in recent fiscals, details of which are given below. Sustained negative cash flow could adversely impact our business, financial condition and results of operations.

There can be no assurance that our net cash flows shall be positive in the future. Any negative cash flows in the future over extended periods, or significant negative cash flows in the short term, could materially impact our ability to operate our business and implement our growth plans. As a result, our cash flows, business, future financial performance and results of operations could be materially and adversely affected.

2. Disruptions in Travel and Hospitality Services or Breach of Customer Data Security Could Adversely Affect Our Business Operations, Reputation, and Financial Performance.

Our business operations are highly dependent on the consistent and uninterrupted availability of travel-related services such as airline, train, and bus ticketing, as well as hotel accommodations and related hospitality services. Any disruption, cancellation, or shortage in the supply of these services, or any significant rise in their costs, could adversely impact our operations, turnover, and profitability. Such disruptions may occur due to various factors including adverse market conditions, strikes or industrial actions by airline or transport personnel, hotel staff or airport authorities, grounding of aircraft, safety or maintenance issues, or financial instability within the airline or hospitality sectors.

In addition, as part of our core operations, we collect, process, and store a large volume of sensitive and confidential information, including personal and financial data of our customers, travel agents, suppliers, and employees. This data is increasingly susceptible to cybersecurity risks such as malware, phishing, ransomware, or other forms of unauthorized access and data breaches. Any such incident could result in the loss or misuse of confidential information, leading to reputational harm, potential legal actions, regulatory penalties, and financial liabilities.

Furthermore, with the growing emphasis on data protection and privacy compliance in India, including under evolving regulatory frameworks, our Company may face additional obligations to strengthen its data protection



infrastructure. Any failure or perceived failure to comply with applicable data privacy laws and security standards could expose us to penalties and increase our compliance and operational costs. Collectively, any prolonged service disruption, increase in travel service costs, or compromise of customer data could materially and adversely affect our business operations, financial condition, results of operations, and reputation.

3. The travel industry is intensely competitive, and we may not be able to effectively compete in the future.

The travel market is intensely competitive. Our success depends upon our ability to compete effectively against numerous established and emerging competitors, including other online travel agencies, traditional offline travel companies, travel research companies, both in India and outside India. Factors affecting our competitive success include, among other things, price, availability and variety of travel services and products, brand recognition, customer service including ease of use and accessibility, customer loyalty, reliability of products and services, fees charged to customers and technology. Some of our competitors may have significantly greater financial, marketing, more experienced management and other resources than us and certain of our competitors have a longer history of established businesses and reputations in the Indian travel market as compared to us due to which they may offer more services and facilities at similar or competitive prices. In addition, entry of global online travel agencies in India could also alter the competitive landscape of the industry in the future.

Further, we may also face increased competition from new entrants and existing players that are continuously developing new travel products and services. If we fail to continuously improve our travel products and services and fail to diversify our platform, or source better technology for quality travel products and services tailored to accommodate our customers' evolving requirements, at a competitive pace, we may lose customers to our competitors and fail to attract new customers.

4. We have significant working capital requirements, and any inability to arrange adequate working capital may adversely affect our business, financial condition, results of operations, and cash flows.

The Issue proceeds is proposed to be utilized towards meeting our working capital requirements, which are based on certain management assumptions and internal estimates. For further details regarding these estimates and assumptions, please refer to the section titled "Objects of the Issue" beginning on page 39 of this Draft Letter of Offer.

The actual working capital requirements of our Company may vary significantly from such estimates due to various factors, including external circumstances, other financial condition or business strategies, changes in business volumes, economic and market conditions, revisions in payment terms with customers and suppliers, or unforeseen expenses. Any such variations may require additional funding to sustain our operations and growth.

To meet any shortfall in working capital, we may be required to raise additional funds through borrowings or other means. Incurrence of additional debt may increase our finance costs and repayment obligations and could subject us to restrictive covenants, thereby affecting our liquidity and operational flexibility. Conversely, if we are unable to secure such additional financing on favorable terms, or at all, our ability to execute projects, maintain inventory, or meet our operational and financial commitments may be adversely impacted.

While our management believes that our internal accruals and proposed Issue proceeds will be sufficient to meet our present working capital requirements, there can be no assurance that we will continue to generate adequate internal resources or obtain timely external financing in the future. Any inability to meet our working capital requirements could adversely affect our business operations, profitability, cash flows, and overall financial condition.

5. Dependence on Leased Premises for Our Registered Office from Related Parties and Risks Arising from Non-Renewal or Termination of Such Lease Arrangements May Adversely Affect Our Business Operations and Financial Condition.

Our Registered Office is situated on premises taken on lease from related parties and is not owned by the Company. Any disruption in our rights as a tenant due to early termination or non-renewal of the lease agreements could materially impact our operations.

There is no assurance that we will be able to renew the lease agreements on favorable terms or within the required timelines. A disruption in occupancy rights or an inability to secure continued access to these premises may negatively affect our business operations, financial condition, and results.



6. Our Company logo " \*\* is not registered with Registrar of Trademark; any infringement of our brand name or failure to get it registered may adversely affect our business. Further, any kind of negative publicity or misuse of our brand name could hamper our brand building efforts and our future growth strategy could be adversely affected.

Our Company has made an application for registration with the Registrar of Trademark for registration of logo

If we are unable to register the intellectual property in the future in our name or any objection on the same may require us to change our logo and hence may loose on the goodwill created so far. Further, the same may involve costly litigations and penal provisions if some legal consequences arise if someone from outside use our name and logo of the Company. We believe that our future growth and competitiveness would depend on our ability to establish and strengthen our brand. We cannot guarantee that we will be able to make a lasting brand image with our clients and other people in the absence of a logo. Although, we believe that our present systems are adequate to protect our confidential information and intellectual property, there can be no assurance that our intellectual property data, trade secrets or proprietary technology will not be copied, infringed or obtained by third parties. Further, our efforts to protect our intellectual property may not be adequate and may lead to erosion of our business value and our operations could be adversely affected. This may lead to litigations and any such litigations could be time consuming and costly and their outcome cannot be guaranteed. Our Company may not be able to detect any unauthorized use or take appropriate and timely steps to enforce or protect our intellectual property, which may adversely affect our business, financial condition and results of operations.

### 7. Failure to Maintain Quality Customer Service May Adversely Affect Our Business.

Our business is significantly affected by the overall size of our customer base, which is determined by our ability to provide quality customer service. We provide customer support at all stages of our customers' trips, through e-mail and tele call -based support. If we fail to provide quality customer service, our customers may be less inclined to book travel products and services with us or recommend us to new customers, and may channel their bookings through our competitors. Our ability to ensure satisfactory customer experience for a large part depends on our travel suppliers' ability to provide high-quality travel products and services. If these service providers experience difficulty in meeting our requirements for quality and customer service standards including any operational or system interruptions, our reputation could suffer and our business could be adversely affected. As we increase the number of third-party services available through our platform, we may not be able to adequately monitor or assure the quality of these services, and an increase in customer dissatisfaction may adversely impact our business. In the event one or more of our contracts with such service providers is terminated on short notice, we may be unable to find alternative service providers on commercially reasonable terms, or at all. Further, the quality of the service provided by a new or replacement service provider may not be up to the standards.

Our business can also be adversely affected by customer complaints relating to the non-performance or substandard performance of our services, our operations, and quality of products. Customer complaints may relate to the miscommunication or misunderstanding on tour arrangements, rescheduling and processing refunds, inaccurate descriptions of hotel rooms and quality of amenities available, as well as matters which would not involve any default or deficiency on our part. If our customers are dissatisfied with the travel products and services provided, they may channel their bookings through our competitors and may even demand refunds from us for poor service quality.

#### 8. Absence of Long-Term Customer Contracts May Impact Revenue Stability

Our business operates primarily on a travel package and purchase order basis, without entering into long-term contractual arrangements or exclusive agreements with our customers. We do not have binding commitments from customers for future business, nor do we engage in exclusive marketing tie-ups or appoint dedicated agents to secure and manage our client relationships.

As a result, our revenue is highly dependent on the volume of repeat business and the strength of our ongoing customer relationships. The absence of long-term contracts limits our visibility on future revenues and creates uncertainty regarding the continuity of business from existing customers. Any adverse changes in customer buying behavior, seasonal fluctuations, shifting travel trends, macroeconomic factors, or the entry of new competitors offering more attractive packages could impact customer retention.

Further, the loss of one or more significant customers, reduction in the volume of business received from them, or a failure to acquire new customers on a consistent basis may lead to a decline in our revenue and profitability. Since



our operations are not backed by guaranteed orders, even minor disruptions or delays in customer decision-making or order placement can materially impact our cash flows and working capital cycle.

### 9. External Events and Disruptions in the Travel Industry May Adversely Affect Our Business and Financial Performance

Our business is inherently linked to the performance and overall health of the travel and tourism industry, which is particularly vulnerable to external, unpredictable, and uncontrollable events. Factors such as natural calamities, terrorist incidents, regional or geopolitical conflicts, global health emergencies (including pandemics like COVID-19), airline safety concerns, and other catastrophic occurrences can significantly reduce travel activity and consumer sentiment. Such events not only impact travel demand but also disrupt operations across key service providers, including airlines, hotels, and ground transport. In the past, India has witnessed several natural disasters—such as the floods in Mumbai (2005), Assam (2012), Uttarakhand (2013), Jammu & Kashmir (2014), Chennai (2015), Kerala (2018), and Odisha (2019)—many of which occurred in major tourist destinations and resulted in widespread travel cancellations and reduced bookings.

If similar incidents occur in the future, particularly in regions that are popular travel hubs, it could lead to large-scale disruptions in travel plans, impact our customer volumes, and reduce revenues. Moreover, prolonged or repeated occurrences of such disruptions could also have a cascading effect on travel-related infrastructure, service availability, and overall market confidence.

### 10. Dependence on Manpower and Workforce Related Disruptions May Adversely Impact Our Business Operations and Cash Flows

Our business operations are heavily reliant on the availability and efficiency of our workforce, particularly permanent employees who are involved in the execution and management of travel services. Any disruption in the availability of skilled manpower whether due to shortages, employee disputes, strikes, work stoppages, or increased wage demands could delay service delivery, affect customer satisfaction, and negatively impact our revenues and cash flows.

Furthermore, our ability to maintain a stable workforce at competitive compensation rates is subject to market dynamics and labour availability. If we are unable to attract or retain the required number of employees to manage tours or provide operational support in a timely manner, it may lead to execution delays and service inefficiencies. Additionally, we are subject to various labour laws and government regulations related to employee welfare, including provisions concerning minimum wages, working hours, occupational safety, insurance, and other statutory benefits. Any adverse changes to these regulations—such as stricter compliance requirements, increased costs of employee welfare, or mandated improvements in working conditions—may result in higher operational costs and impact our profitability. Failure to effectively manage our workforce requirements and comply with evolving labour regulations may materially and adversely affect our business operations, financial performance, and growth prospects.

# 11. Our Company's ability to pay dividends in the future will depend upon our future earnings, financial condition, cash flows, working capital requirements and capital expenditures. Any inability to declare a dividend may adversely affect the trading price of our Equity Shares.

Historically, our Company has never declared any dividend since incorporation. We may retain all our future earnings, if any, for use in the operations and expansion of our business. As a result, we may not declare dividends in the foreseeable future. Any future determination as to the declaration and payment of dividends will be at the discretion of our Board of Directors and will depend on factors that our Board of Directors deem relevant, including among others, our results of operations, financial condition, cash requirements, business prospects and any other financing arrangements. The declaration and payment of dividends will be recommended by the Board of Directors and / or approved by the shareholders, at their discretion, subject to the provisions of the Articles of Association and applicable law, including the Companies Act, 2013. Realization of a gain on shareholders investments may largely depend upon the appreciation of the price of our Equity Shares. There can be no assurance that our Equity Shares will appreciate in value.

### 12. If we are unable to source business opportunities effectively, we may not achieve our financial objectives.

Our ability to achieve our financial objectives will depend on our ability to identify, evaluate and accomplish business opportunities. To grow our business, we will need to hire, train, supervise and manage new employees



and to implement systems capable of effectively accommodating our growth. However, we cannot assure you that any such employees will contribute to the success of our business or that we will implement such systems effectively. Failure to source business opportunities effectively could have a material adverse effect on our business, financial condition and results of operations. It is also possible that the strategies used by us in the future may be different from those presently in use. No assurance can be given that our analyses of market and other data or the strategies we use or plans in future to use will be successful under various market conditions.

## 13. We are dependent on a number of key personnel, including our senior management, and the loss of our inability to attract or retain such persons could adversely affect our business, results of operations and financial condition.

Our performance depends largely on the efforts and abilities of our senior management and other key personnel. We believe that the inputs and experience of our senior management and key managerial personnel are valuable for the development of business and operations and the strategic directions taken by our Company. We cannot assure you that we will be able to retain these employees or find adequate replacements in a timely manner, or at all. We may require a long period of time to hire and train replacement personnel when qualified personnel terminate their employment with our Company. We may also be required to increase our levels of employee compensation more rapidly than in the past to remain competitive in attracting employees that our business requires. The loss of the services of such persons may have an adverse effect on our business and our results of operations. The continued operations and growth of our business is dependent upon our ability to attract and retain personnel who have the necessary and required experience and expertise. Competition for qualified personnel with relevant industry expertise in India is intense. A loss of the services of our key personnel may adversely affect our business, results of operations and financial condition.

### 14. Deficiency in Our Services May Lead to Customer Claims and Adversely Impact Our Results of Operations.

Our Company operates under standard terms and conditions agreed upon with customers, which are primarily governed by the general provisions of contract law in India. While there is no sector-specific regulatory framework for the delivery of our services, any perceived or actual deficiency in service quality, delays, or failure to meet customer expectations may expose us to claims for compensation or legal disputes.

Such claims, even if governed by contractual limitations, can result in reputational damage, customer attrition, and legal or financial liabilities. In the event of a breach of contractual obligations or failure to resolve customer grievances efficiently, our business operations, financial condition, and profitability could be adversely affected.

### 15. Failure to Effectively Manage the Risks Associated with Social Media Could Adversely Impact Our Reputation and Business.

The rapid proliferation of social media platforms such as blogs, networking sites, video-sharing platforms, and other internet-based communication tools has significantly increased public visibility and consumer interaction with brands in India. While these platforms offer opportunities for engagement and marketing, they also pose significant reputational risks.

Social media content is often published instantly and without verification, which means inaccurate or misleading information related to our Company can spread rapidly and widely. Regardless of its accuracy, such content can negatively influence public perception, harm our brand image, and adversely impact our business operations, customer trust, and financial performance. The resulting reputational damage may occur swiftly and without providing us an adequate opportunity to respond or correct misinformation.

Additional risks include unauthorized disclosure of confidential or proprietary information, exposure of personally identifiable customer data, employee or third-party misconduct, cyber fraud, or coordinated misinformation campaigns. Any such incidents could lead to increased compliance and mitigation costs, potential legal exposure, regulatory scrutiny, or loss of customer confidence. Inadequate monitoring or management of our social media presence, or the inability to respond effectively to adverse online activity, could materially and adversely affect our reputation, business prospects, financial condition, and operating results.

### 16. Our insurance coverage may be inadequate to protect us against potential losses, which could materially affect our business and financial condition.

Our Company currently does not maintain any insurance policy for its registered office or any keyman insurance policy. In the absence of such coverage, any unforeseen event, damage, or liability may result in financial loss that



cannot be compensated. Furthermore, our business operations are exposed to risks such as system failures, employee misconduct, and other unforeseen incidents that could adversely impact our performance and profitability. We cannot assure you that such events will not occur or that their impact will not be significant. Additionally, we may, in the future, be unable to obtain or maintain insurance coverage of the type, level, or cost we consider appropriate. Any event for which we are inadequately insured, or any successful claims exceeding our insurance limits, as well as increases in premium costs or changes in policy terms, could materially and adversely affect our business, financial condition, results of operations, and cash flows.

### 17. We have entered into certain transactions with related parties. These transactions or any future transactions with our related parties could potentially involve conflicts of interest.

We have entered into certain transactions with related parties and may continue to do so in future. Our Company has entered into such transactions due to easy proximity and quick execution. Additionally, our Company believes that all our related party transactions have been conducted on an arm's length basis and were/are in compliance with all applicable laws and regulations for the time being in force. Our Company may enter into such transactions in future also and we cannot assure that in such events there would be no adverse effect on results of our operations, although going forward, all related party transactions that we may enter will be subject to board or shareholder approval, as under the Companies Act, 2013 and the SEBI LODR Regulations.

### 18. Excessive dependence on Red Fort Capital Finance Company Limited in respect of Loan facilities obtained by our Company.

Our Company has availed a significant portion of its credit facilities, including term loans and working capital loans, from Red Fort Capital Finance Company Limited. As a result, we are substantially dependent on this lender for meeting our ongoing funding requirements and business operations. Any adverse change in the terms of these facilities, withdrawal or reduction of such limits, or any delay or default in servicing these obligations could have a significant impact on our liquidity position and day-to-day operations.

Further, any deterioration in our relationship with Red Fort Capital Finance Company Limited or any default under the existing loan agreements may adversely affect our credit profile and restrict our ability to raise funds from other financial institutions or banks in the future. In such circumstances, our Company may face challenges in refinancing or repaying the outstanding borrowings, which could, in turn, adversely impact our financial performance, business growth, and overall financial stability.

# 19. Our lenders have created charge over our assets including machinery, book debts, and stock in respect of the financial facilities availed, and any default in repayment could adversely affect our business operations and financial condition.

Our Company has availed various secured loan facilities from banks and financial institutions, for which charges have been created over certain assets of the Company, including immovable properties, plant and machinery, book debts, receivables, inventories, and other movable and current assets. These securities have been provided as collateral to secure the repayment of loans and other credit facilities availed from our lenders.

In the event of any delay or default in repayment of principal or interest obligations under these facilities, the lenders may enforce their security interest and take possession or dispose of the charged assets in accordance with the applicable laws. Such enforcement actions could disrupt our business operations, adversely affect our production and cash flows, and result in the loss of key operational assets. Moreover, any such event could also adversely impact our creditworthiness, limit our ability to obtain future financing, and have a material adverse effect on our business, financial position, and results of operations.

### 20. We Could Be Adversely Affected by Employee Misconduct, Errors, or Failure to Adhere to Internal Policies and Controls, Which May Impact Our Financial Performance, Reputation, and Operations.

Our business operations depend significantly on the integrity, competence, and diligence of our employees, management personnel, and agents. Instances of employee misconduct, negligence, or errors whether deliberate or inadvertent could expose our Company to financial loss, regulatory scrutiny, reputational harm, or legal proceedings. Such acts may include failure to comply with internal policies and procedures, misrepresentation, manipulation of accounts, unauthorized transactions, misappropriation of funds, or violation of applicable laws and regulations.



Although our Company has implemented reporting systems, and compliance frameworks to detect and prevent such occurrences, there can be no assurance that these measures will always be effective. Employee misconduct or operational errors can be difficult to detect, particularly if concealed through collusion or falsification of records. Any such lapse could result in financial penalties, litigation, customer dissatisfaction, and erosion of investor and stakeholder confidence.

Further, our Company is also vulnerable to risks arising from inadequate adherence to system controls, technological failures, or breaches of data security. A significant fraud, internal control failure, or data compromise caused by employees, agents, customers, or third parties could have a material adverse effect on our business operations, financial condition, results of operations, and overall reputation.

### 21. Delays or defaults in customer payments could adversely affect our financial condition, cash flows, and overall business operations.

Our business operations are significantly dependent on the timely realization of payments from our customers. We are exposed to risks relating to delays or defaults in payments, which in turn may adversely affect our liquidity, working capital cycle, and overall financial performance. The creditworthiness and financial stability of our customers are critical to our ability to collect receivables in a timely manner. Any delay in payment or default by our customers may compel us to extend additional working capital or borrowings to finance ongoing operations, thereby increasing our interest and financing costs.

Although our Company has not faced any material instance of customer default in the past, there can be no assurance that all customers will continue to meet their payment obligations on time in the future. Factors such as financial instability, cash flow constraints, weak business performance, or adverse macroeconomic conditions could impair their ability to make timely payments. Any significant delay or non-recovery of dues from our customers could adversely impact our revenues, cash flows, and overall financial condition.

### 22. Major Frauds, Lapses in Internal Controls, or System Failures Could Adversely Impact Our Company's Business, Financial Performance, and Reputation.

Our Company is exposed to risks arising from potential lapses or inadequacies in internal controls, fraud, human error, or system failures. Despite the existence of established policies, internal control mechanisms, and monitoring procedures, there can be no assurance that all such measures will be completely effective in preventing or detecting frauds or operational irregularities in a timely manner. Instances such as non-adherence to approved processes, manipulation of accounts, misappropriation of funds, unauthorized transactions, or collusion by employees or third parties could result in financial loss and reputational damage.

Additionally, our operations rely on the effective functioning of internal systems, software, and information technology infrastructure. Any breakdown, malfunction, data breach, or security compromise could disrupt our operations, lead to loss of critical information, and expose us to regulatory actions or litigation.

Significant frauds, control failures, or prolonged system outages could also result in erosion of stakeholder confidence, financial penalties, additional compliance costs, and reputational harm. Such incidents may materially and adversely affect our business operations, financial condition, results of operations, and overall market reputation.

### 23. Our company has undisputed outstanding statutory dues including income-tax, cess, and other statutory dues with regulatory authorities

Our Company has certain undisputed outstanding statutory dues payable to various regulatory authorities, including liabilities relating to income tax, cess, and other statutory payments. These arrears pertain to dues under the Income Tax Act, 1961, the Employees' Provident Fund and Miscellaneous Provisions Act, 1952, the Employees' State Insurance Act, 1948, and the West Bengal State Tax on Professions, Trades, Callings and Employment Rules, 1979, which are yet to be remitted. The Company is currently in the process of reconciling these amounts and intends to clear all such outstanding statutory dues with the respective authorities in due course.

### 24. As a listed company, our Company is subject to certain obligations and reporting requirements under the SEBI Listing Regulations, and we must comply with other SEBI regulations as may be applicable to us.

Our Company was listed on the BSE SME Platform on September 5, 2024. Subsequent to our listing, the Company was penalized by BSE for delays in submission of its financial results for the half year ended September 30, 2024,



and the year ended March 31, 2025. The Company has duly paid the penalties levied for the said delays. These instances of non-compliance have subjected the Company to regulatory penalties and may have exposed it to reputational risks and increased scrutiny by the stock exchange and other regulatory authorities.

There can be no assurance that our Company will always be able to comply with all regulatory and disclosure requirements in a timely manner in the future. Any further delay, default, or non-compliance may result in additional monetary penalties, restrictions on certain corporate actions, or other disciplinary measures by the regulators. Such actions could adversely affect our reputation, investor confidence, ability to raise capital in the future, and overall business operations. For further details, please refer to the section titled "Summary of the Letter of Offer" beginning on page 31.

#### RISKS RELATING TO RIGHTS ISSUE AND OBJECTS OF THE ISSUE

# 25. A Substantial Portion of the Net Proceeds from the Rights Issue Is Proposed to Be Utilized for Working Capital Requirements, and Any Inefficient Deployment or Variation in These Requirements May Adversely Affect Our Liquidity, Operations, and Financial Performance.

Our Company proposes to allocate approximately ₹1,700.00 lakhs, representing a substantial portion of the Net Proceeds from the Rights Issue, towards meeting its working capital requirements. Working capital is essential for supporting day-to-day operations, including financing inventory, trade receivables, other current assets, trade payables, and short-term financial obligations. The quantum and deployment of working capital are inherently dynamic and influenced by several factors such as business growth, operational costs, customer credit cycles, market conditions, and seasonality in demand.

Unlike investments in fixed assets, the working capital cycle is continuously revolving, and therefore, monitoring and effectively managing its utilization poses ongoing operational challenges. Any inefficiency, diversion, or delay in deployment of the working capital funds could strain our liquidity, disrupt operations, and adversely affect our cash flows and profitability. Furthermore, the actual working capital requirements may differ from current estimates due to changes in our business operations, market fluctuations, or external economic factors.

In the event of any shortfall, our Company may need to seek additional financing through borrowings or other sources, which could increase our financial costs and affect our overall financial position. The proposed utilization of the Net Proceeds is based on management's current business plans, internal estimates, and prevailing market conditions. However, these assumptions are subject to change due to factors beyond our control, including market volatility, competitive pressures, and macroeconomic developments. Consequently, our management may, at its discretion and in accordance with applicable laws, revise or reschedule the proposed deployment of funds. Any such change could have an adverse impact on our business operations, liquidity position, and financial condition.

### 26. Our Promoter has expressed its intention to subscribe to the extent of only 50% of its rights entitlement.

Our Promoter has confirmed its intention to subscribe to the minimum extent of 50% of its respective Rights Entitlement in this Rights Issue. It has further undertaken to subscribe to any portion of the Rights Equity Shares that remain unsubscribed after considering all valid applications, including additional applications from public shareholders, subject to compliance with the minimum public shareholding requirements under Regulation 38 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015. Accordingly, for the Rights Issue to be fully subscribed without triggering additional subscription by the Promoter, the public shareholders will need to (i) fully subscribe to their Rights Entitlement and (ii) apply for additional Rights Equity Shares. In the event of under-subscription by public shareholders, the unsubscribed portion will be allocated to the Promoter and Promoter Group as per their undertaking. Although our Promoter is obligated to subscribe to the unsubscribed portion, its limited participation in its own Rights Entitlement may be perceived negatively by investors and could impact overall investor sentiment. There can be no assurance that public shareholders will subscribe to their full entitlements. Any such perception or shortfall in public participation may affect the market performance of our Equity Shares and could have an adverse effect on our reputation and investor confidence.

### 27. If our Company does not receive the minimum subscription of 90% of the total Issue Size, the Issue may fail.

In the event our Company does not receive the minimum subscription of 90% of the total Issue Size or the subscription level falls below 90% of the total Issue Size after the Issue Closing Date on account of withdrawal of Applications or technical rejections or any other reason, our Company shall refund the entire subscription amount received not later than four days from the closure of the Rights Issue or any other period as may be prescribed under



applicable law. In the event there is a delay in making a refund of the subscription monies, our Company shall be required to pay interest for the delayed period at such a rate prescribed under applicable law. The Objects of the Issue for which funds are being raised, are based on our management estimates and any bank or financial institution or any independent agency has not appraised the same. The deployment of funds in the project is entirely at our discretion, based on the parameters as mentioned in the chapter titles "Objects of the Issue. The fund requirement and deployment, as mentioned in the "Objects of the Issue" on page 39 of this Letter of Offer is based on the estimates of our management and has not been appraised by any bank or financial institution or any other independent agency. These fund requirements are based on our current business plan.

We cannot assure that the current business plan will be implemented in its entirety or at all. In view of the highly competitive and dynamic nature of our business, we may have to revise our business plan from time to time and consequently these fund requirements. The deployment of the funds as stated under chapter "Objects of the Issue" beginning at page 39, is at the discretion of our Board of Directors and is subject to monitoring by external independent agency. Further, we cannot assure that the actual costs or schedule of implementation as stated under chapter Objects of the Issue will not vary from the estimated costs or schedule of implementation. Any such variance may be on account of one or more factors, some of which may be beyond our control. Occurrence of any such event may delay our business plans and/or may have an adverse bearing on our expected revenues and earnings.

### 28. The Rights Entitlement of Eligible Equity Shareholders holding Equity Shares in physical form may lapse in case they fail to furnish the details of their demat account to the Registrar.

In accordance with Regulation 77A of the SEBI ICDR Regulations read with the SEBI ICDR Master Circular, the credit of Rights Entitlements and Allotment of Rights Equity Shares shall be made in dematerialized form only. Prior to the Issue Opening Date, our Company shall credit the Rights Entitlements to the demat accounts of the Eligible Equity Shareholders holding the Equity Shares in dematerialised form.

Our Company has opened a separate demat suspense escrow account (namely, "TRAVELS AND RENTALS LIMITED RIGHTS ISSUE SUSPENSE ESCROW DEMAT ACCOUNT") and would credit Rights Entitlements on the basis of the Equity Shares: (a) held by Eligible Equity Shareholders which are held in physical form as on Record Date; or (b) which are held in the account of the Investor Education and Protection Fund ("IEPF") authority; or which of the Eligible Equity Shareholder whose demat accounts are frozen or where the Equity Shares are lying in the unclaimed/ suspense escrow account / demat suspense account (including those pursuant to Regulation 39 of the SEBI LODR Regulations) or details of which are unavailable with our Company or with the Registrar on the Record Date or where Equity Shares have been kept in abeyance or where entitlement certificate has been issued or where instruction has been issued for stopping issue or transfer or where letter of confirmation lying in escrow account; or (d) where credit of the Rights Entitlements have returned/reversed/failed for any reason; or (e) where ownership is currently under dispute, including any court or regulatory proceedings or where legal notices have been issued, if any or (f) such other cases where our Company is unable to credit Rights Entitlements for any other reasons.

Our Company shall credit the Rights Entitlements to the Demat Suspense Account on the basis of information available with our Company and to serve the interest of relevant Eligible Equity Shareholders to provide them with a reasonable opportunity to participate in the Issue. The credit of the Rights Entitlements to the Demat Suspense Account by our Company does not create any right in favour of the relevant Eligible Equity Shareholders for transfer of Rights Entitlement to their demat account or to receive any Equity Shares in the Issue.

With respect to the Rights Entitlements credited to the Demat Suspense Account, the Eligible Equity Shareholders are required to provide relevant details / documents as acceptable to our Company or the Registrar (such as applicable regulatory approvals, self-attested PAN and client master sheet of demat account, details/ records confirming the legal and beneficial ownership of their respective Equity Shares, etc.) to our Company or the Registrar no later than two clear Working Days prior to the Issue Closing Date to enable credit of their Rights Entitlements by way of transfer from the Demat Suspense Account to their demat account at least one day before the Issue Closing Date, to enable such Eligible Equity Shareholders to make an application in this Issue, and this communication shall serve as an intimation to such Eligible Equity Shareholders in this regard. In the event that the Eligible Equity Shareholders are not able to provide relevant details to our Company or the Registrar by the end of two clear Working Days prior to the Issue Closing Date, Rights Entitlements credited to the Demat Suspense Account shall lapse and extinguish in due course and such Eligible Equity Shareholder shall not have any claim against our Company and our Company shall not be liable to any such Eligible Equity Shareholder in any form or manner and such lapsing of Rights Entitlement may dilute and adverse impact the interest of certain Eligible Equity Shareholders. For details, please see "Terms of the Issue" on page 59.



# 29. The Eligible Equity Shareholders holding Equity Shares in physical form will have no voting rights in respect of Rights Equity Shares until they provide details of their demat account and Rights Equity Shares are transferred to such demat account from the demat suspense account thereafter.

In accordance with the SEBI ICDR Master Circular, the credit of Rights Entitlement and Allotment of Equity Shares shall be made in dematerialised form only. Accordingly, the Rights Entitlements of the Physical Shareholders shall be credited in a suspense escrow demat account opened by our Company during the Issue Period. The Physical Shareholders are requested to furnish the details of their demat account to the Registrar no later than two clear Working Days prior to the Issue Closing Date to enable the credit of their Rights Entitlements in their demat accounts at least one day before the Issue Closing Date. The Rights Entitlements of the Physical Shareholders who do not furnish the details of their demat account to the Registrar no later than two clear Working Days prior to the Issue Closing Date, shall lapse. Further, pursuant to a press release dated December 3, 2018 issued by the SEBI, with effect from April 1, 2019, a transfer of listed Equity Shares cannot be processed unless the Equity Shares are held in dematerialized form (except in case of transmission or transposition of Equity Shares). For further information, see "*Terms of the Issue*" on page 59.

#### 30. Applicants to this Issue are not allowed to withdraw their Applications after the Issue Closing Date.

In terms of the SEBI ICDR Regulations, Applicants in this Issue are not allowed to withdraw their Applications after the Issue Closing Date. The Allotment in this Issue and the credit of such Rights Equity Shares to the Applicant's demat account with its depository participant shall be completed within such period as prescribed under the applicable laws. There is no assurance, however, that material adverse changes in the international or national monetary, financial, political or economic conditions or other events in the nature of force majeure, material adverse changes in our business, results of operations or financial condition, or other events affecting the Applicant's decision to invest in the Rights Equity Shares, would not arise between the Issue Closing Date and the date of Allotment in this Issue. Occurrence of any such events after the Issue Closing Date could also impact the market price of our Equity Shares. The Applicants shall not have the right to withdraw their applications in the event of any such occurrence. We cannot assure you that the market price of our Equity Shares will not decline below the Issue Price. To the extent the market price for our Equity Shares declines below the Issue Price after the Issue Closing Date, the shareholder will be required to purchase Rights Equity Shares at a price that will be higher than the actual market price for the Equity Shares at that time. Should that occur, the shareholder will suffer an immediate unrealized loss as a result. We may complete the Allotment even if such events may limit the Applicants' ability to sell our Equity Shares after this Issue or cause the trading price of our Equity Shares to decline.

### 31. Failure to exercise or sell the Rights Entitlements will cause the Rights Entitlements to lapse without compensation and result in a dilution of shareholding.

Rights Entitlements that are not exercised prior to the end of the Issue Closing Date will expire and become null and void, and Eligible Equity Shareholders will not receive any consideration for them. The proportionate ownership and voting interest in our Company of Eligible Equity Shareholders who fail (or are not able) to exercise their Rights Entitlements will be diluted. Even if you elect to sell your unexercised Rights Entitlements, the consideration you receive for them may not be sufficient to fully compensate you for the dilution of your percentage ownership of the equity share capital of our Company that may be caused as a result of the Issue. Renouncees may not be able to apply in case of failure of completion of renunciation through off-market transfer in such a manner that the Rights Entitlements are credited to the demat account of the Renouncees prior to the Issue Closing Date. Further in case, the Rights Entitlements do not get credited in time, in case of On Market Renunciation, such Renouncee will not be able to apply in this Issue with respect to such Rights Entitlements. For details, see "Terms of the Issue" on page 59.

### 32. Our Company will not distribute the Letter of Offer and other Issue related materials to overseas shareholders who have not provided an address in India for service of documents.

We will not distribute the Issue Material to the shareholders who have not provided an address in India for service of documents. The Issue Material will not be distributed to addresses outside India on account of restrictions that apply to circulation of such materials in various overseas jurisdictions. In the case that Eligible Equity Shareholders have provided their valid e-mail address, the Letter of Offer will be sent only to their valid e-mail address and in the case that such Eligible Equity Shareholders have not provided their e-mail address, then the Letter of Offer will be dispatched, on a reasonable effort basis, to the Indian addresses provided by them.

However, the Companies Act, 2013 requires companies to serve documents at any address which may be provided by the members as well as through e-mail. Presently, there is lack of clarity under the Companies Act, 2013 and the rules thereunder with respect to distribution of Issue Material in overseas jurisdictions where such distribution may be



prohibited under the applicable laws of such jurisdiction. While our Company will request its shareholders to provide an address in India for the purposes of distribution of Issue Material, our Company cannot assure that the regulator would not adopt a different view with respect to compliance with the Companies Act, 2013 and may subject our Company to fines or penalties.

### 33. Overseas shareholders may not be able to participate in the Company's future rights offerings or certain other equity issues.

If our Company offers or causes to be offered to holders of its Equity Shares rights to subscribe for additional Equity Shares or any right of any other nature, our Company will have discretion as to the procedure to be followed in making such rights available to overseas holders of the Equity Shares or in disposing of such rights for the benefit of such holders. For instance, our Company may not offer such rights to the holders of Equity Shares who have a registered address in the United States unless: (i) a registration statement is in effect, if a registration statement under the U.S. Securities Act is required in order for the Company to offer such rights to holders and sell the securities represented by such rights; or (ii) the offering and sale of such rights or the underlying securities to such holders are exempt from registration under the provisions of the U.S. Securities Act. Our Company has no obligation to prepare or file any registration statement. Accordingly, shareholders who have a registered address in the United States may be unable to participate in future rights offerings and may experience a dilution in their holdings as a result.

### 34. Investors will be subject to market risks until our Equity Shares credited to the investor's demat account are listed and permitted to trade.

Investors can start trading the Rights Equity Shares Allotted to them only after they have been credited to an investor's demat account, are listed and permitted to trade. Since our Equity Shares are currently traded on the BSE SME, investors will be subject to market risk from the date they pay for the Rights Equity Shares to the date when trading approval is granted for the same. Further, there can be no assurance that the Rights Equity Shares allocated to an investor will be credited to the investor's demat account or that trading in such Equity Shares will commence in a timely manner.

### 35. Any future issuance of Equity Shares by our Company or sales of our Equity Shares by any of our Company's significant shareholders may adversely affect the trading price of our Equity Shares.

Any future issuance of Equity Shares by us could dilute your shareholding. Any such future issuance of our Equity Shares or sales of our Equity Shares by any of our significant shareholders may also adversely affect the trading price of our Equity Shares, and could impact our ability to raise capital through an offering of our securities. We cannot assure you that we will not issue further equity shares or that the shareholders will not dispose of, pledge, or otherwise encumber their equity shares. In addition, any perception by investors that such issuances or sales might occur could also affect the trading price of our Equity Shares.

### 36. The Rights Equity Shares may experience price and volume fluctuations.

The market price of the Rights Equity Shares can be volatile as a result of several factors beyond our control, including volatility in the Indian and global securities markets, our results of operations, the performance of our competitors, developments in the Indian finance and lending sector, changing perceptions in the market about investments in this sector in India, investor perceptions of our future performance, adverse media reports about us or our sector, changes in the estimates of our performance or recommendations by financial analysts, significant developments in India's economic liberalization and deregulation policies, and significant developments in India's fiscal regulations. In addition, the stock exchange may experience significant price and volume fluctuations, which may have a material adverse effect on the market price of the Rights Equity Shares.

General or industry specific market conditions or stock performance or domestic or international macroeconomic and geopolitical factors unrelated to our performance also affect the price of the Rights Equity Shares. In particular, the stock market as a whole recently experienced extreme price and volume fluctuations that have affected the market price of many companies in ways that may have been unrelated to the companies' operating performances. For these reasons, investors should not rely on recent trends to predict future share prices, results of operations or cash flow and financial condition.

#### 37. No market for the Rights Entitlements may develop and the price of the Rights Entitlements may be volatile.

No assurance can be given that an active trading market for the Rights Entitlements will develop on the Stock Exchange during the Renunciation Period or that there will be sufficient liquidity in Rights Entitlements trading during



this period. The trading price of the Rights Entitlements will not only depend on supply and demand for the Rights Entitlements, which may be affected by factors unrelated to the trading in the Equity Shares, but also on the quoted price of the Equity Shares, amongst others. Factors affecting the volatility of the price of the Equity Shares, as described herein, may magnify the volatility of the trading price of the Rights Entitlements, and a decline in the price of the Equity Shares will have an adverse impact on the trading price of the Rights Entitlements. Since the trading of the Rights Equity Shares will be on a separate segment compared to the Equity Shares on the floor of the Stock Exchange, the trading of Rights Equity Shares may not track the trading of Equity Shares.

### 38. Foreign investors are subject to foreign investment restrictions under Indian law that limit our Company's ability to attract foreign investors, which may adversely affect the market price of the Equity Shares.

Under the foreign exchange regulations currently in force in India, transfers of shares between nonresidents and residents and issuances of shares to non-residents are freely permitted (subject to certain exceptions) if they comply with the requirements specified by the RBI. If such issuances or transfers of shares are not in compliance with such requirements or fall under any of the specified exceptions, then prior approval of the RBI will be required. We have undertaken or recorded such transactions in the past based on a bona fide interpretation of the law. We cannot assure you that our interpretation would be upheld by the Indian regulators. Any change in such interpretation could impact the ability of our Company to attract foreign investors.

In addition, shareholders who seek to convert the Indian Rupee proceeds from a sale of shares in India into foreign currency and repatriate that foreign currency from India will require a no-objection or tax clearance certificate from the income tax authority. Additionally, the Government of India may impose foreign exchange restrictions in certain emergency situations, including situations where there are sudden fluctuations in interest rates or exchange rates, where the Government of India experiences extreme difficulty in stabilizing the balance of payments, or where there are substantial disturbances in the financial and capital markets in India. These restrictions may require foreign investors to obtain the Government of India's approval before acquiring Indian securities or repatriating the interest or dividends from those securities or the proceeds from the sale of those securities. We cannot assure you that any approval required from the RBI or any other government agency can be obtained on any particular terms, or at all.

### 39. Rights of shareholders under Indian law may differ or may be more limited than under the laws of other jurisdictions.

The Companies Act and rules made thereunder, the rules and regulations issued by SEBI and other regulatory authorities, the Memorandum of Association, and the Articles of Association govern the corporate affairs of our Company. Indian legal principles relating to these matters and the validity of corporate procedures, directors' fiduciary duties and liabilities, and shareholders' rights may differ from those that would apply to a company in another jurisdiction. In accordance with the provisions of the Companies Act the voting rights of an equity shareholder in a company shall be in proportion to the share of a person in the paid-up equity share capital of that company. Further, Section 106(1) of the Companies Act states that the articles of a company may provide that no member shall exercise any voting right in respect of any shares registered in his name on which any calls or other sums presently payable by him have not been paid, or in regard to which the company has exercised any right of lien.

### 40. You may be subject to Indian taxes arising out of capital gains on the sale of the Rights Equity Shares.

Under the current Indian Income Tax provisions, all transactions of purchase and sales of securities on Indian stock exchange are subject to levy of securities transaction tax (STT) which will be collected by respective stock exchange on which the securities are transacted. Accordingly, the Indian Income Tax Act has special capital gains tax provisions for all transactions of purchase and sale of equity shares carried out on the Indian Stock Exchange. Under the current Indian Income Tax provisions, unless specifically exempted, capital gains arising from the sale of equity shares in an Indian company are generally taxable in India.

### 41. Investors may be restricted in their ability to exercise pre-emptive rights under Indian law and thereby may suffer future dilution of their ownership position.

Under the Companies Act, a company having share capital and incorporated in India must offer its holders of equity shares pre-emptive rights to subscribe and pay for a proportionate number of shares to maintain their existing ownership percentages before the issuance of any new equity shares, unless the pre-emptive rights have been waived by adoption of a special resolution by the company. However, if the law of the jurisdiction the investors are in, does not permit them to exercise their pre-emptive rights without our Company filing an offering document or registration statement with the applicable authority in such jurisdiction, the investors will be unable to exercise their pre-emptive rights unless our Company makes such a filing. If we elect not to file a registration statement, the new securities may be issued to a custodian, who may sell the securities for the investor's benefit. The value such custodian receives on



the sale of such securities and the related transaction costs cannot be predicted. In addition, to the extent that the investors are unable to exercise pre-emptive rights granted in respect of the Equity Shares held by them, their proportional interest in our Company would be reduced.

### **EXTERNAL RISK FACTORS**

42. Our business, results of operations and cash flows is substantially affected by prevailing economic, political and other conditions in emerging and global markets.

The Indian economy and securities markets are influenced by economic, political and market conditions in India and globally, including adverse geopolitical conditions. We are incorporated in India, and a substantial amount of our operations are located in India and overseas. As a result, we are highly dependent on prevailing economic conditions in India and the other emerging and global markets and our results of operations and cash flows are significantly affected by factors influencing the economy in these countries. Factors that may adversely affect the economy, and hence our results of operations and cash flows, may include:

- any increase in interest rates or inflation;
- any exchange rate fluctuations;
- any scarcity of credit or other financing, resulting in an adverse impact on economic conditions and scarcity of financing for our expansions;
- prevailing income conditions among consumers and corporates;
- volatility in, and actual or perceived trends in trading activity on, the relevant market's principal stock exchange;
- changes in tax, trade, fiscal or monetary policies;
- political instability, terrorism or military conflict in the region or globally;
- occurrence of natural or man-made disasters;
- prevailing regional or global economic conditions, including in the relevant country's principal export markets;
- any downgrading of debt rating by a domestic or international rating agency;
- instability in financial markets;
- disruption of supply chain and logistics arrangements; and
- other significant regulatory or economic developments in or affecting India or the emerging and global markets.

In addition, any slowdown or perceived slowdown in the Indian economy or the economy of any emerging and global market, or in specific sectors of such economies, could adversely impact our business, results of operations and financial condition and the price of the Equity Shares.

43. Inflation in India could have an adverse effect on our profitability and if significant, on our financial condition.

Inflation rates in India have been volatile in recent years, and such volatility may continue in the future. India has experienced high inflation in the recent past. Increased inflation can contribute to an increase in interest rates and increased costs to our business, including increased costs of salaries, and other expenses relevant to our business.

High fluctuations in inflation rates may make it more difficult for us to accurately estimate or control our costs. Any increase in inflation in India can increase our expenses, which we may not be able to pass on to our customers, whether entirely or in part, and the same may adversely affect our business and financial condition. In particular, we might not be able to reduce our costs or increase our rates to pass the increase in costs on to our customers. In such case, our business, results of operations, cash flows and financial condition may be adversely affected.

44. Natural calamities, climate change and health epidemics and pandemics such as COVID-19 could adversely affect the economy of countries globally and our business, financial condition and results of operations. In addition, hostilities, terrorist attacks, civil unrest and other acts of violence could adversely affect our business, results of operations and financial condition.

Several countries have experienced natural calamities, such as earthquakes and floods in recent years. Natural calamities could have an adverse impact on the global economy which, in turn, could adversely affect our business, and may damage or destroy our borrowers' assets or projects. Any of these natural calamities could adversely affect our business, results of operations and financial condition. A number of countries in Asia, including India, as well as countries in other parts of the world, are susceptible to contagious diseases and, for example, have had confirmed cases of the highly pathogenic H7N9, H5N1 and H1N1 strains of influenza in birds and swine. In addition, the COVID-19 pandemic, had caused a worldwide health crisis and economic downturn. Any future outbreak of health



epidemics may restrict the level of business activity in affected areas, which may, in turn, adversely affect our business.

# 45. Changing laws, rules and regulations and legal uncertainties may adversely affect our business, prospects, results of operations and cash flows. Further, failure to comply with the existing laws and regulations applicable to our business could subject our Company to enforcement actions and penalties and otherwise harm our business.

The regulatory environment in which we operate is subject to changes as may be notified by the government and other regulatory authorities. Any change in Indian tax laws could adversely affect our operations. The Government of India announced the Union Budget for 2025-2026, following which the Finance Bill, 2025 ("Finance Bill") was introduced in the Lok Sabha on February 1, 2025. The Finance Bill has received assent from the President of India on March 29, 2025, and has been enacted as the Finance Act, 2025. The Finance Act, 2025 has made various amendments to taxation laws in India. Unfavorable changes in or interpretations of existing, or the promulgation of new laws, rules and regulations including foreign investment laws governing our business, operations, and group structure could result in us being deemed to be in contravention of such laws or may require us to apply for additional approvals. We may incur increased costs relating to compliance with such new requirements, which may also require management time and other resources, and any failure to comply may adversely affect our business, results of operations and prospects. Uncertainty in the applicability, interpretation or implementation of any amendment to, or change in, governing law, regulation or policy, including by reason of an absence, or a limited body, of administrative or judicial precedent, may be time consuming as well as costly for us to resolve and may affect the viability of our current business or restrict our ability to grow our business in the future.

We cannot predict whether any new tax laws or regulations impacting our operations will be enacted, what the nature and impact of the specific terms of any such laws or regulations will be or whether, if at all, any laws or regulations would have an adverse effect on our business. There is no certainty on how such amendments will impact our business, operations or the industry in which we operate. In addition, unfavorable changes in or interpretations of existing, or the promulgation of new laws, rules and regulations including foreign investment laws governing our business, operations and group structure could result in us being deemed to be in contravention of such laws or may require us to apply for additional approvals. We may incur increased costs relating to compliance with such new requirements, which may also require management time and other resources, and any failure to comply may adversely affect our business, results of operations and prospects. Uncertainty in the applicability, interpretation or implementation of any amendment to, or change in, governing law, regulation or policy, including by reason of an absence, or a limited body, of administrative or judicial precedent may be time consuming as well as costly for us to resolve and may affect the viability of our current business or restrict our ability to grow our business in the future.

### 46. We are subject to regulatory, economic, social and political uncertainties and other factors beyond our control.

We are incorporated in India and we conduct our corporate affairs and our business in India. Our Equity Shares are listed on BSE SME. Consequently, our business, operations, financial performance and the market price of our Equity Shares will be affected by interest rates, government policies, taxation, social and ethnic instability and other political and economic developments affecting India.

Factors that may adversely affect the Indian economy, and hence our results of operations may include:

- any exchange rate fluctuations, the imposition of currency controls and restrictions on the right to convert or repatriate currency or export assets;
- any scarcity of credit or other financing in India, resulting in an adverse effect on economic conditions in India and scarcity of financing for our expansions;
- prevailing income conditions among Indian customers and Indian corporations;
- epidemic or any other public health in India or in countries in the region or globally, including in India's various neighbouring countries;
- hostile or war like situations with the neighbouring countries;
- macroeconomic factors and central bank regulation, including in relation to interest rates movements which may in turn adversely impact our access to capital and increase our borrowing costs;
- volatility in, and actual or perceived trends in trading activity on, India's principal stock exchange;
- decline in India's foreign exchange reserves which may affect liquidity in the Indian economy;
- downgrading of India's sovereign debt rating by rating agencies; and
- difficulty in developing any necessary partnerships with local businesses on commercially acceptable terms and/or a timely basis.



# 47. In the event we undertake future acquisitions, mergers or similar corporate actions, we may potentially be affected by competition law in India and any adverse application or interpretation of the Competition Act could in turn adversely affect our business, results of operations and financial condition.

The Competition Act, 2002 ("Competition Act") was enacted for the purpose of preventing practices that have or are likely to have an adverse effect on competition in India and has mandated the Competition Commission of India to prevent such practices. Under the Competition Act, any arrangement, understanding or action, whether formal or informal, which causes or is likely to cause an appreciable adverse effect on competition ("AAEC") is void and attracts substantial penalties.

Further, any agreement among competitors which, directly or indirectly, involves determination of purchase or sale prices, limits or controls production, or shares the market by way of geographical area or number of customers in the relevant market is presumed to have an appreciable adverse effect in the relevant market in India and shall be void. The Competition Act also prohibits abuse of a dominant position by any enterprise. The Competition Commission of India (Procedure in regard to the transaction of business relating to combinations) Regulations ("Combination Regulations") require acquisitions of shares, voting rights, assets or control or mergers or amalgamations that cross the prescribed asset and turnover based thresholds to be mandatorily notified to, and preapproved by, the Competition Commission of India. The Competition Act aims to, among other things, prohibit all agreements and transactions which may have an appreciable adverse effect in India. Consequently, all agreements entered into by us in future could be within the purview of the Competition Act. Further, the Competition Commission of India has extra-territorial powers and can investigate any agreements, abusive conduct or combination occurring outside of India if such agreement, conduct or combination has an appreciable adverse effect in India.

The Competition (Amendment) Act, 2023 ("Competition Amendment Act") was notified on April 11, 2023, which amends the Competition Act and gives the CCI additional powers to prevent practices that harm competition and the interests of consumers. These amendments include the introduction of deal value thresholds for assessing whether a merger or acquisition qualifies as a "combination", expedited merger review timelines, codification of the lowest standard of "control" and enhanced penalties for providing false information or a failure to provide material information. Such amendment to the Competition Act will result in additional costs for compliance, which in turn may adversely affect our business, results of operations, cash flows and prospect.

#### 48. Companies operating in India are subject to a variety of taxes and surcharges.

Tax and other levies imposed by the central and state governments in India that affect our tax liability include central and state taxes and other levies, income tax, value added tax, turnover tax, service tax, stamp duty, tax on dividends and other special taxes and surcharges which are introduced on a temporary or permanent basis from time to time. Moreover, the central and state tax scheme in India is extensive and subject to change from time to time. The central or state government may in the future increase the corporate income tax it imposes. Any such future increases or amendments may affect the overall tax efficiency of companies operating in India and may result in significant additional taxes becoming payable. Additional tax exposure could adversely affect our business, cash flows and results of operations.

### 49. Fluctuation of the Rupee against foreign currencies may have an adverse effect on the price of the Equity Shares.

Any adverse movement in currency exchange rates during the time that it takes to undertake such conversion may reduce the net dividend to foreign investors. In addition, any adverse movement in currency exchange rates during a delay in repatriating outside India the proceeds from a sale of Equity Shares, for example, because of a delay in regulatory approvals that may be required for the sale of Equity Shares may reduce the proceeds received by Equity shareholders. For example, the exchange rate between the Rupee and the U.S. Dollar has fluctuated substantially in recent years and may continue to fluctuate substantially in the future, which may have an adverse effect on the trading price of our Equity Shares and returns on our Equity Shares, independent of our operating results.

### 50. Rights of shareholders under Indian laws may differ to those under the laws of other jurisdictions.

Indian laws and legal principles related to corporate procedures, directors' fiduciary duties and liabilities, and shareholders' rights may differ from those that would apply to a company in another jurisdiction. Shareholders' rights under Indian law, including in relation to class actions, may not be as extensive as shareholders' rights under the laws of other countries or jurisdictions. Investors may face challenges in asserting their rights as shareholder in an Indian company than as a shareholder of an entity in another jurisdiction.

Consequently, partnership firm was converted into a company under the name "Travels & Rentals Private Limited" on September 23, 1996, under the Companies Act, 1956, bearing CIN U60221WB1996PTC081439, issued by the Registrar of Companies, Kolkata.

In line with its long-term growth objectives, our Company was subsequently converted into a public limited company under the provisions of the Companies Act, 2013, and a fresh Certificate of Incorporation was issued on April 05, 2024, reflecting the new name "Travels & Rentals Limited" and updated CIN U60221WB1996PLC081439, by the Registrar of Companies, Central Processing Centre.

Our Company achieved an important milestone by getting listed on the BSE SME Platform on September 05, 2024, marking its transition into the public capital markets.

Travels & Rentals Limited has taken franchisee of Lufthansa City Center International GmbH (LCCI) since 2010 and has been granted right to operate under "Business Plus Lufthansa City Center" in India in the year 2013. LCCI has world-wide travel agency franchisee network in around 600 locations in 110 countries. Being a franchisee of Lufthansa City Center, we are authorized to use the brand name of Lufthansa City Center for our business activities.

Travels & Rentals offers a comprehensive range of travel-related products and services for end-to-end travel solutions, including airline tickets, hotels and tour packages, rail tickets as well as ancillary value-added services such as travel insurance, passport & visa processing and tickets.

We are bestowed with more than 25 years of experience by designing personalised tour packages. We are accredited by IATA (International Air Transport Association, Geneva, Switzerland), recognized by Ministry of Tourism, Government of India, member of TAAI (Travel Agent Association of India) and member of IATO (Indian Association of Tour Operators).

### (B) \*INDUSTRY OVERVIEW:

According to the World Travel & Tourism Council (WTTC), India's travel and tourism sector contributed US\$ 199.6 billion to the country's economy in 2022. This marked a notable recovery from 2021, when the sector contributed US\$ 178 billion, with projections indicating a surge to US\$ 512 billion by 2028. The sector is expected to grow at an annual rate of 7.1%, and WTTC's Economic Impact Report 2023 stated that the sector's GDP contribution grew by 5.9% in that year. The direct contribution of travel and tourism to India's GDP is projected to increase at an annual rate of 7–9% between 2019 and 2030.

Employment generated by the tourism sector has also been significant. In FY23, the sector supported 7.6 crore (76 million) jobs, and it is estimated that by 2029, it will account for approximately 53 million jobs. The domestic travel market in India is expected to grow from US\$ 75 billion in FY20 to US\$ 125 billion by FY27. Foreign Tourist Arrivals (FTAs) have shown a strong rebound post-pandemic. In 2023, India recorded 9.52 million FTAs, reflecting a 47.9% increase over the previous year. Provisional data for 2024 indicates FTAs have reached 9.66 million. In December 2023 alone, FTAs stood at 1,070,163, while cumulative FTAs from January to December 2023 totaled 9,236,108, compared to 6,437,467 in 2022. During January–October 2024, FTAs reached 7,680,628, up from 7,470,383 in the same period in 2023. A significant share of foreign visitors—26.52% in 2023—came to reconnect with the Indian diaspora. Foreign Exchange Earnings (FEE) from tourism were US\$ 28.1 billion in 2023, and US\$ 18.17 billion during the January–July 2024 period.

Domestic visitor spending grew by 20.4% in 2022, narrowing the gap with 2019 levels to just 14.1%. Meanwhile, international visitor spending surged by 81.9% in 2022, although it remained 40.4% below pre-pandemic levels. International tourist arrivals are projected to reach 30.5 billion by 2028, generating over US\$ 59 billion in revenue. The expansion of international hotel chains has been another major trend, with their market share rising to 47% in 2020 and 50% in 2022. Furthermore, the cumulative Foreign Direct Investment (FDI) equity inflow into the hotel and tourism sector between April 2000 and September 2024 stood at Rs. 1,14,320 crore (US\$ 13.16 billion), accounting for 2.56% of total FDI inflows across all sectors. This data underscores the steady and promising growth trajectory of India's travel and tourism industry across various segments.

### **Justification for Holding Period:**

Particulars	Details
Sundry Debtors	Our Gross turnover has been increased from ₹8,028.00 Lakh to ₹16,857.00 Lakhs from FY 2022-23 to FY 2024-25. The data as on September 30, 2025 is for the period of six months only and hence is not truly comparable.  Our Net Revenue from operations has been increased from ₹567.05 Lakhs in FY 2022-23 to ₹1,145.32 Lakhs in FY 2024-25 wherein sundry debtors has been increased from ₹876.27 Lakhs to ₹3,031.40 Lakhs for the same period. The data as on September 30, 2025 is for the period of six months only and hence is not truly comparable. The sundry Debtors holding period depends on our gross turnover which is ultimate realisation from our customer, but being in travel industry, our turnover in books shown as Net Turnover. The sundry debtor holding periods depends on lots of factor like prevailing market condition, Seasonable effect, customers demand etc. Sometimes, we have to also offer extra credit period to boost the topline and retained the clients or to get new clients. Going forward, we are estimating to maintain the Debtor holding period at levels of 65 days from Fiscal 2026 onwards as per our affordability to increase the top line as well to retain present & future customers as per the demand and market practice.



Cameo Corporate Services Limited is our Registrar and Share Transfer Agent. All investor grievances received by us have been handled by the Registrar and Share Transfer Agent in consultation with our Company Secretary and Compliance Officer.

### Procedure for Applications by certain categories of Investors

Procedure for Applications by FPIs

In terms of applicable FEMA Rules and the SEBI FPI Regulations, investments by FPIs in the Equity Shares is subject to certain limits, i.e., the individual holding of an FPI (including its investor group (which means multiple entities registered as foreign portfolio investors and directly and indirectly having common ownership of more than 50% of common control)) shall be below 10% of our post-Issue Equity Share capital. In case the total holding of an FPI or investor group increases beyond 10% of the total paid-up Equity Share capital of our Company, on a fully diluted basis or 10% or more of the paid-up value of any series of debentures or preference shares or share warrants that may be issued by our Company, the total investment made by the FPI or investor group will be re-classified as FDI subject to the conditions as specified by SEBI and RBI in this regard. Further, the aggregate limit of all FPIs investments is up to the sectoral cap applicable to the sector in which our Company operates.



FPIs are permitted to participate in this Issue subject to compliance with conditions and restrictions which may be specified by the Government from time to time. FPIs who wish to participate in the Issue are advised to use the Application Form for non-residents. Subject to compliance with all applicable Indian laws, rules, regulations, guidelines and approvals in terms of Regulation 21 of the SEBI FPI Regulations, an FPI may issue, subscribe to or otherwise deal in offshore derivative instruments (as defined under the SEBI FPI Regulations as any instrument, by whatever name called, which is issued overseas by an FPI against securities held by it that are listed or proposed to be listed on any recognised stock exchange in India, as its underlying) directly or indirectly, only in the event (i) such offshore derivative instruments are issued only to persons registered as Category I FPI under the SEBI FPI Regulations; (ii) such offshore derivative instruments are issued only to persons who are eligible for registration as Category I FPIs (where an entity has an investment manager who is from the Financial Action Task Force member country, the investment manager shall not be required to be registered as a Category I FPI); (iii) such offshore derivative instruments are issued after compliance with 'know your client' norms; and (iv) compliance with other conditions as may be prescribed by SEBI.

An FPI issuing offshore derivative instruments is also required to ensure that any transfer of offshore derivative instruments issued by or on its behalf, is carried out subject to inter alia the following conditions:

- (a) such offshore derivative instruments are transferred only to persons in accordance with the SEBI FPI Regulations; and
- (b) prior consent of the FPI is obtained for such transfer, except when the persons to whom the offshore derivative instruments are to be transferred to are pre approved by the FPI.

### Procedure for Applications by AIFs, FVCIs, VCFs and FDI route

The SEBI VCF Regulations and the SEBI FVCI Regulations prescribe, among other things, the investment restrictions on VCFs and FVCIs registered with SEBI. Further, the SEBI AIF Regulations prescribe, among other things, the investment restrictions on AIFs.

As per the SEBI VCF Regulations and SEBI FVCI Regulations, VCFs and FVCIs are not permitted to invest in listed companies pursuant to rights issues. Accordingly, applications by VCFs or FVCIs will not be accepted in this Issue. Further, venture capital funds registered as Category I AIFs, as defined in the SEBI AIF Regulations, are not permitted to invest in listed companies pursuant to rights issues. Accordingly, applications by venture capital funds registered as category I AIFs, as defined in the SEBI AIF Regulations, will not be accepted in this Issue. Other categories of AIFs are permitted to apply in this Issue subject to compliance with the SEBI AIF Regulations. Such AIFs having bank accounts with SCSBs that are providing ASBA in cities / centres where such AIFs are located are mandatorily required to make use of the ASBA facility. Otherwise, applications of such AIFs are liable for rejection.

#### Procedure for Applications by NRIs

Investments by NRIs are governed by the FEMA Rules. Applications will not be accepted from NRIs that are ineligible to participate in this Issue under applicable securities laws.

As per the FEMA Rules, an NRI or Overseas Citizen of India ("OCI") may purchase or sell capital instruments of a listed Indian company on repatriation basis, on a recognised stock exchange in India, subject to the conditions, inter alia, that the total holding by any individual NRI or OCI will not exceed 5% of the total paid- up equity capital on a fully diluted basis or should not exceed 5% of the paid-up value of each series of debentures or preference shares or share warrants issued by an Indian company and the total holdings of all NRIs and OCIs put together will not exceed 10% of the total paid-up equity capital on a fully diluted basis or shall not exceed 10% of the paid-up value of each series of debentures or preference shares or share warrants. The aggregate ceiling of 10% may be raised to 24%, if a special resolution to that effect is passed by the general body of the Indian company.

Further, in accordance with press note 3 of 2020, the FDI Policy has been amended to state that all investments by entities incorporated in a country which shares land border with India or where the beneficial owner of an investment into India is situated in or is a citizen of any such country ("Restricted Investors"), will require prior approval of the Government of India. It is not clear from the press note whether or not an issue of the Rights Equity Shares to Restricted Investors will also require prior approval of the Government of India and each Investor should seek independent legal advice about its ability to participate in the Issue. In the event such prior approval has been obtained, the Investor shall intimate our Company and the Registrar about such approval within the Issue Period.

Procedure for Applications by Mutual Funds



A separate application can be made in respect of each scheme of an Indian mutual fund registered with SEBI and such applications shall not be treated as multiple applications. The applications made by asset management companies or custodians of a mutual fund should clearly indicate the name of the concerned scheme for which the application is being made.

No Mutual Fund scheme shall invest more than 10% of its net asset value in equity shares or equity related instruments of any single company provided that the limit of 10% shall not be applicable for investments in case of index funds or exchange traded funded or sector or industry specific schemes. No Mutual Fund under all its schemes should own more than 10% of any company's paid-up share capital carrying voting rights.

## Procedure for Applications by Systemically Important Non-Banking Financial Companies ("NBFC-SI")

In case of an application made by NBFC-SI registered with RBI, (a) the certificate of registration issued by RBI under Section 45IA of RBI Act, 1934 and (b) net worth certificate from its statutory auditors or any independent chartered accountant based on the last audited financial statements is required to be attached to the application.

## Last date for Application

The last date for submission of the duly filled in the Application Form or a plain paper Application is [●], i.e., Issue Closing Date. Our Board or any committee thereof may extend the said date for such period as it may determine from time to time, subject to the Issue Period not exceeding 30 days from the Issue Opening Date (inclusive of the Issue Opening Date).

## • Fractional Entitlements

The Rights Equity Shares shall be credited to a temporary ISIN which will be frozen until the receipt of the final listing/trading approvals from the Stock Exchanges. ## • Rights of Holders of Equity Shares of our Company

#### VIII. GENERAL TERMS OF THE ISSUE

#### • Market Lot

The Equity Shares of our Company shall be tradable only in dematerialized form. The market lot for Equity Shares in dematerialised mode is 3,000 (Three Thousand) Equity Shares.

#### • Joint Holders

Where two or more persons are registered as the holders of any Equity Shares, they shall be deemed to hold the same as the joint holders with the benefit of survivorship subject to the provisions contained in our Articles of Association. In case of Equity Shares held by joint holders, the Application submitted in physical mode to the Designated Branch of the SCSBs would be required to be signed by all the joint holders (in the same order as appearing in the records of the Depository) to be considered as valid for allotment of Equity Shares offered in this Issue.

#### • Nomination

Nomination facility is available in respect of the Equity Shares in accordance with the provisions of the Section 72 of the Companies Act, 2013 read with Rule 19 of the Companies (Share Capital and Debenture) Rules, 2014.

Our Company will send through email and speed post, the Letter of Offer, the Application Form, the Rights Entitlement Letter and other Issue material only to the Eligible Equity Shareholders who have provided Indian address. In case such Eligible Equity Shareholders have provided their valid e-mail address, the Letter of Offer, the Application Form, the Rights Entitlement Letter and other Issue material will be sent only to their valid e-mail address and in case such Eligible Equity Shareholders have not provided their e-mail address, then the Letter of Offer, the Application Form, the Rights Entitlement Letter and other Issue material will be physically dispatched, on a reasonable effort basis, to the Indian addresses provided by them.

Further, the Letter of Offer will be sent/dispatched to the Eligible Equity Shareholders who have provided their Indian address and who have made a request in this regard.

All notices to the Eligible Equity Shareholders required to be given by our Company shall be published in one English language national daily newspaper with wide circulation, one Hindi language national daily newspaper with wide circulation and one Malayalam language daily newspaper with wide circulation (Malayalam being the regional language of Ernakulam, where our Registered Office is situated).

#### • Offer to Non-Resident Eligible Equity Shareholders/Investors



As per Rule 7 of the FEMA Rules, RBI has given general permission to Indian companies to issue rights equity shares to non-resident equity shareholders including additional rights equity shares. The liability prescribed under Section 447 of the Companies Act, 2013 for fraud involving an amount of at least ₹10 Lakhs or 1% of the turnover of the company, whichever is lower, includes imprisonment for a term which shall not be less than six months extending up to 10 years and fine of an amount not less than the amount involved in the fraud, extending up to three times such amount (provided that where the fraud involves public interest, such term shall not be less than three years.) Further, where the fraud involves an amount less than ₹10 Lakhs or 1% of the turnover of the company, whichever is lower, and does not involve public interest, any person guilty of such fraud shall be punishable with imprisonment for a term which may extend to five years or with fine which may extend to ₹50 Lakhs or with both.

## RESTRICTIONS ON FOREIGN OWNERSHIP OF INDIAN SECURITIES

There are two routes through which foreign investors may invest in India. One is the "automatic route", where no government approval is required under Indian foreign exchange laws to make an investment as long as it is within prescribed thresholds for the relevant sector. The other route is the "government route", where an approval is required under foreign exchange laws from the relevant industry regulator, prior to the investment.

Foreign investment in Indian securities is regulated through the Industrial Policy, 1991, of the Government of India and FEMA. While the Industrial Policy, 1991, of the Government of India, prescribes the limits and the conditions subject to which foreign investment can be made in different sectors of the Indian economy, FEMA regulates the precise manner in which such investment may be made. The Union Cabinet, as provided in the Cabinet Press Release dated May 24, 2017, has given its approval for phasing out the FIPB. Under the Industrial Policy, 1991, unless specifically restricted, foreign investment is freely permitted in all sectors of the Indian economy up to any extent and without any prior approvals, but the foreign investor is required to follow certain prescribed procedures for making such investment. Accordingly, the process for foreign direct investment ("FDI") and approval from the Government of India will now be handled by the concerned ministries or departments, in consultation with the Department for Promotion of Industry and Internal Trade, Ministry of Commerce and Industry, Government of India (formerly known as the Department of Industrial Policy and Promotion) ("DPIIT"), Ministry of Finance, Department of Economic Affairs, FIPB section, through a memorandum dated June 5, 2017, has notified the specific ministries handling relevant sectors.

The Government has, from time to time, made policy pronouncements on FDI through press notes and press releases. The DPIIT issued the Consolidated FDI Policy Circular of 2020 ("FDI Policy") by way of circular bearing number DPIIT file number 5(2)/2020-FDI Policy dated October 15, 2020, which with effect from October 15, 2020, consolidates and supersedes all previous press notes, press releases and clarifications on FDI issued by the DPIIT that were in force and effect as on October 15, 2020. The Government of India has from time to time made policy pronouncements on FDI through press notes and press releases which are notified by RBI as amendments to FEMA. In case of any conflict between FEMA and such policy pronouncements, FEMA prevails.

As per Rule 7 of the Foreign Exchange Management (Non-debt Instruments) Rules, 2019, the RBI has given general permission to Indian companies to issue rights securities to non-resident shareholders including additional rights securities. Further, as per the Master Direction on Foreign Investment in India dated January 4, 2018 issued by the RBI, non-residents may, inter alia, (i) subscribe for additional securities over and above their rights entitlement; (ii) renounce the securities offered to them either in full or part thereof in favour of a person named by them; or (iii) apply for the securities renounced in their favour. Applications received from NRIs and non-residents for allotment of Rights Equity Shares shall be inter alia, subject to the conditions imposed from time to time by the RBI under the FEMA in the matter of refund of Application Money, Allotment of Rights Equity Shares and issue of Allotment advice. This Draft Letter of Offer, Rights Entitlement Letter and Application Form shall be dispatched to non-resident Eligible Equity Shareholders at their Indian address only.
